

Dupré Minerals – Aerosol Fire Extinguisher - Product Warranty

In this product warranty:

- **we, us** or **our** means Dupré Minerals Limited; and
- **you** or **your** means the person originally buying the goods from us.

Consumer Rights laws says goods must be as described, fit for purpose and of satisfactory quality. During the expected lifespan of your product you're entitled to the following:

- *Up to 30 days: if your product is faulty, you can get a refund*
- *Up to six months: if your product can't be repaired or replaced, then you're entitled to a full refund in most cases*
- *Up to five years: if the goods do not last a reasonable length of time you may be entitled to some money back*

You **DON'T** have a legal right to a refund or replacement just because you change your mind.

We warrant that during the warranty period, the product will be free from defects in materials and workmanship.

This product warranty does not cover any damage due to: (a) transportation; (b) storage; (c) improper use; (d) failure to follow the product instructions or to perform any preventive maintenance; (e) modifications; (f) unauthorised repair; (g) normal wear and tear; or (h) external causes such as accidents, abuse, or other actions or events beyond our reasonable control.

We do not accept responsibility for loss or damage to property or human life when the product is used and we do not give guarantee, or warranty, or suggest, or imply that the product will extinguish all fires, regardless of fire type
